
**NOTICE OF WITHDRAWAL OF REQUEST
FOR EXTENSION OF TIME**

City of Gainesville, Gainesville Regional Utilities (GRU), by and through undersigned counsel, hereby withdraws its Request for Extension of Time to file a petition for formal administrative proceedings in accordance with Chapter 120, Florida Statutes. GRU filed its last Request for Extension of Time on January 5, 1998, in response to the "Intent to Issue Title V Air Operation Permit" (Permit No. 0010005-001-AV) for the J.R. Kelly Generating Station in Alachua County, Florida, in order to negotiate certain changes in the draft Title V air operation permit with the Department of Environmental Protection (Department). Based on GRU's written comments and subsequent discussions with Department representatives, GRU and the Department have come to an agreement on the issues involving the above-referenced draft Title V permit. The agreement between GRU and the Department is contained in the draft Proposed Title V Air Operation Permit received from the Department, a copy of which is attached to this Notice, with the following additional changes initiated subsequently and characterized by the Department as "non-substantive": (1) p. 12, Subsection B., the heading "Monitoring of Operations" will be

deleted, (2) p. 12, Conditions B.10 and B.11. will be moved under the heading "Test Methods and Procedures" and will be renumbered B.14 and B.10, respectively, and (3) the other conditions under Subsection B. will be renumbered accordingly. Also, the following Attachments to the draft Proposed Title V Permit are not included with this Notice of Withdrawal but must be made part of the Final Title V Permit: (1) Appendix SS-1, Stack Sampling Facilities (version dated 10/07/96), (2) Table 297.310-1, Calibration Schedule (version dated 10/06/96), (3) Phase II Permit Application received January 2, 1996, (4) Alternate Sampling Procedure: ASP Number 97-B-01 (including Order Correcting Scrivener's Error dated July 2, 1997), and (5) Order Extending Permit Expiration Date. Accordingly, GRU hereby withdraws its Request for Extension of Time, expressly conditioned upon the Department's issuance of the Final Title V Air Operation Permit in accordance with the Department's agreement with GRU, as described above.
