## REQUEST FOR EXTENSION OF TIME

By and through undersigned counsel, City of Gainesville, Gainesville Regional Utilities (GRU) hereby requests, pursuant to Florida Administrative Code Rule 62-110.106(4), an enlargement of time to and including September 1, 1999, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, GRU states the following:

- 1. On or about October 15, 1998, GRU received from the Department of Environmental Protection (Department) an "Intent to Issue Title V Air Operation Permit" (Revised Draft Permit No. 0010006-001-AV) for the GRU Deerhaven Generating Station located in Alachua County, Florida. GRU subsequently filed several extensions of time, until July 1, 1999, to preserve its right to file a Petition for Administrative Proceeding on this permit.
- 2. On or about June 18, 1999, GRU received from the Department an "Intent to Issue Title V Air Operation Permit" (Second Revised Draft Permit No. 0010006-001-AV) for the GRU Deerhaven Generating Station. The Department issued this Second Revised Draft based on progressing negotiations.

- 3. The Department's cover letter to the Revised Draft permit states that the Revised Draft Title V permit issued in October of 1998 is withdrawn. In reliance on this representation, GRU hereby files this Request for Extension of Time on the Second Revised Draft permit, and understands that no further extensions of time are needed to preserve its rights in relation to the Revised Draft Title V permit because it has been effectively withdrawn. Nonetheless, insofar as the Revised Draft Title V permit may be determined to still be in effect, GRU respectfully requests that this Request for Extension of Time apply to both the Revised and the Second Revised Draft Title V permits.
- 4. Based on GRU's review, the Second Revised Draft permit and associated documents contain several provisions that warrant clarification or correction.
- 5. This request is filed simply as a protective measure to avoid waiver of GRU's right to challenge certain conditions contained in the Second Revised Draft Title V permit. Grant of this request will not prejudice either party, but will further their mutual interest and hopefully avoid the need to file a petition and proceed to a formal administrative hearing.
- 6. A representative of GRU has discussed this request for an extension until September 1, 1999, with Tom Cascio of the Department's Division of Air Resources Management and he has no objection.

WHEREFORE, GRU respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Title V Air Operation Permit for Revised/Second Revised Draft Permit No. 0010006-001-AV be formally extended to and including September 1, 1999. If this Request is denied, GRU requests 10 days from the date of denial to file a Petition, if necessary.
