Gulf Power Lansing Smith Generating Plant, Bay County, Florida

Request for Air Construction Permit Extension

On April 4, 2003 Gulf Power requested an extension to their construction permit authorizing replacement of the waterwall tubes in the Lansing Smith Generating Plant Unit 2 boiler. Construction is nearly complete, and Unit 2 is expected to resume operation on or about April 16, 2003. The original permit expires on July 1, 2003. The request for extension is being made not to complete physical construction but rather to accommodate a timely submittal of a title V operating permit application. By regulation, the title V application is due 90 days prior to expiration of the construction permit (i.e., April 2, 2003).

The request for extension was received prior to 60 days before the expiration date. Physical construction is mostly complete. Gulf Power has provided an anticipated date of project completion.

A final permit amendment letter extending the expiration date to January 1, 2004 is attached for your approval and signature.

I recommend your approval.

Dear Mr. Vick:

The Florida Department of Environmental Protection (Department) reviewed your correspondence dated April 4, 2003 in which you requested an extension of the construction permit for the Unit 2 waterwall tube replacement project at the Lansing Smith Generating Plant, Bay County, Florida.

The expiration date is hereby extended from July 1, 2003 to January 1, 2004. All physical construction for the project is scheduled to be completed on or about April 16, 2003 when Unit 2 resumes operation following the tubing replacement outage. This permit modification does not authorize any additional construction. The purpose of the extension is to allow sufficient time following the completion of physical construction for the unit to be operated and tested and for you to file a timely and complete application for a Title V air operation permit.

A person whose substantial interests are affected by the proposed permitting decision may petition for an administrative proceeding (hearing) under Sections 120.569 and 120.57, Florida Statutes (F.S.). The petition must contain the information set forth below and must be filed (received) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Mail Station #35, Tallahassee, Florida, 32399-3000. Petitions filed by the permit applicant or any of the parties listed below must be filed within fourteen days of receipt of this notice of intent. Petitions filed by any persons other than those entitled to written notice under Section 120.60(3), F.S., must be filed within fourteen days of publication of the public notice or within fourteen days of receipt of this notice of intent, whichever occurs first. Under Section 120.60(3), F.S., however, any person who asked the Department for notice of agency action may file a petition within fourteen days of receipt of that notice, regardless of the date of publication. A petitioner shall mail a copy of the petition to the applicant at the address indicated above at the time of filing. The failure of any person to file a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, Florida Administrative Code (F.A.C.).

A petition that disputes the material facts on which the Department's action is based must contain the following information: (a) The name and address of each agency affected and each agency's file or identification number, if known; (b) The name, address, and telephone number of the petitioner, the name, address, and telephone number of the petitioner's representative, if any, which shall be the address for service purposes during the course of the proceeding; and an explanation of how the petitioner's substantial interests will be affected by the agency determination; (c) A statement of how and when petitioner received notice of the agency action or proposed action; (d) A statement of all disputed issues of material fact. If there are none, the petition must so indicate; (e) A concise statement of the ultimate facts alleged, including the specific facts the petitioner contends warrant reversal or modification of the agency's proposed action; (f) A statement of the specific rules or statutes the petitioner contends require reversal or modification of the agency's proposed action; and (g) A statement of the relief sought by the petitioner, stating precisely the action petitioner wishes the agency to take with respect to the agency's proposed action.

A petition that does not dispute the material facts upon which the Department's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301, F.A.C.

Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the Department's final action may be different from the position taken by it in this notice. Persons whose substantial interests will be affected by any such final decision of the Department on the application have the right to petition to become a party to the proceeding, in accordance with the requirements set forth above.

Mediation is not available in this proceeding.

In addition to the above, a person subject to regulation has a right to apply for a variance from or waiver of the requirements of particular rules, on certain conditions, under Section 120.542, F.S. The relief provided by this state statute applies only to state rules, not statutes, and not to any federal regulatory requirements. Mediation is not available in this proceeding. Applying for a variance or waiver does not substitute or extend the time for filing a petition for an administrative hearing or exercising any other right that a person may have in relation to the action proposed in this notice of intent.

The application for a variance or waiver is made by filing a petition with the Office of General Counsel of the Department, 3900 Commonwealth Boulevard, Mail Station #35, Tallahassee, Florida 32399-3000. The petition must specify the following information: (a) The name, address, and telephone number of the petitioner; (b) The name, address, and telephone number of the attorney or qualified representative of the petitioner, if any; (c) Each rule or portion of a rule from which a variance or waiver is requested; (d) The citation to the statute underlying (implemented by) the rule identified in (c) above; (e) The type of action requested; (f) The specific facts that would justify a variance or waiver for the petitioner; (g) The reason why the variance or waiver would serve the purposes of the underlying statute (implemented by the rule); and (h) A statement whether the variance or waiver is permanent or temporary and, if temporary, a statement of the dates showing the duration of the variance or waiver requested.

The Department will grant a variance or waiver when the petition demonstrates both that the application of the rule would create a substantial hardship or violate principles of fairness, as each of those terms is defined in Section 120.542(2), F.S., and that the purpose of the underlying statute will be or has been achieved by other means by the petitioner.

Persons subject to regulation pursuant to any federally delegated or approved air program should be aware that Florida is specifically not authorized to issue variances or waivers from any requirements of any such federally delegated or approved program. The requirements of the program remain fully enforceable by the Administrator of the EPA and by any person under the Clean Air Act unless and until the Administrator separately approves any variance or waiver in accordance with the procedures of the federal program.

This permitting decision is final and effective on the date filed with the clerk of the Department unless a petition is filed in accordance with the above paragraphs or unless a request for extension of time in which to file a petition is filed within the time specified for filing a petition pursuant to Rule 62-110.106, F.A.C., and the petition conforms to the content requirements of Rules 28-106.201 and 28-106.301, F.A.C. Upon timely filing of a petition or a request for extension of time, this order will not be effective until further order of the Department.

This permitting decision is issued pursuant to Chapter 403, F.S. Any party to this permitting decision (order) has the right to seek judicial review of it under Section 120.68, F.S., by filing a notice of appeal under Rule 9.110 of the Florida Rules of Appellate Procedure with the clerk of the Department of Environmental Protection in the Office of General Counsel, Mail Station #35, 3900 Commonwealth Boulevard, Tallahassee, Florida, 32399-3000, and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The notice must be filed within thirty days after this order is filed with the clerk of the Department.

Late last year, Gulf Power received a construction permit to replace waterwall tubing on Unit 2 at the Lansing Smith Electric Generating Plant. The permit expiration date is July 1, 2003 and the project is scheduled to be completed on or about April 16, 2003 when the unit begins operation from the tubing replacement outage. A problem has arisen regarding the timeline for submission of the Title V application for items in the construction permit. The Department reviewed your request dated May 6, 2002 to modify the PSD Permit relative to the maximum heat input rates while firing natural gas. The Department has additionally reviewed the provided summary of initial compliance test data from March 21/27 and April 5/12. According to the supplied information, the Department has concluded that no emissions increase will result from this request. Accordingly, this request is acceptable as indicated herein.

Permit PSD-FL-269 is hereby modified as follows:

The maximum heat input of the combustion turbines is revised from 1751 MMBtu/hr (LHV at 65 degrees F) to 1927 MMBtu/hr (HHV at 65 degrees F) each.

The maximum heat input of the duct burners is revised from 275 MMBtu/hr (LHV at 65 degrees F) to 303 MMBtu/hr (HHV at 65 degrees F) each.

No other changes to the permit are authorized by this action.

Attached for approval and signature is a PSD Permit Modification for the newly installed combined cycle unit at the Lansing Smith Electric Generating Plant. Based upon initial testing, Gulf Power wishes to revise the listed heat inputs to Higher Heating Values (HHV) versus Lower heating Values (LHV). The current limits are 1751 MMBtu/hr and 275 MMBtu/hr for the CT's and Duct burners respectively.

Gulf's request proposes HHV values which we believe to be less than or equal to the current (permitted) LHV ratings. These values are 1927 and 303 MMBtu/hr for the respective components listed above. In summary, we have no reason to believe that the permit modification represents a change of any significance, nor are any emission increases expected.

The modification was publicly noticed in the Panama City News Herald on May 29th and no comments were received.



Permit PSD-FL-269 is hereby modified as follows:

The maximum heat input of the combustion turbines is revised from 1751 MMBtw/hr (LHV at 65 degrees F) to 1927 MMBtw/hr (HHV at 65 degrees F) each.

The maximum heat input of the duct burners is revised from 275 MMBtu/hr (LHV at 65 degrees F) to 303 MMBtu/hr (HHV at 65 degrees F) each.

No other changes to the permit are authorized by this action.

A copy of this letter shall be filed with the referenced permit and shall become part of the permit. This permit modification is issued pursuant to Chapter 403, Florida Statutes. Any party to this order (permit modification) has the right to seek judicial review of it under Section 120.68, F.S., by the filing of a Notice of Appeal under Rule 9.110 of the Florida Rules of Appellate Procedure with the Clerk of the Department of Environmental Protection in the Office of General Counsel, Mail Station 35, 3900 Commonwealth Boulevard, Tallahassee, Florida, 32399-3000, and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. 



Smith Unit 4 & 5 Heat Input CT+DB Mode



Smith Unit 4 & 5 Heat Input PA Mode




Smith Unit 4 & 5 Heat Input Normal Mode (CT+DB) 100-95% Testing Curve

Attached for approval and signature is a PSD Permit Modification for the newly installed combined cycle unit at the Lansing Smith Electric Generating Plant. Based upon initial testing, Gulf Power wishes to revise the listed heat inputs to Higher Heating Values (HHV) versus Lower heating Values (LHV). As per attached, the current limits are 1751 MMBtu/hr and 275 MMBtu/hr for the CT's and Duct burners respectively.

Gulf's request (also attached) proposes HHV values which we believe to be less than or equal to the current (permitted) LHV ratings. Two sources of information (El Paso and Santa Barbara County APCD) suggest that a ratio of HHV/LHV equal to 1.10 is equivalent, whereas a third (British Columbia) utilizes a ratio of HHV/LHV equal to 1.11. In the draft permit, we utilize a value of 1.10 for the HHV/LHV ratio and have no reason to believe that the permit modification represents a change of any significance, nor are any emission increases expected.






Smith Unit 4 & 5 Heat Input CT+DB Mode



Smith Unit 4 & 5 Heat Input PA Mode




Smith Unit 4 & 5 Heat Input Normal Mode (CT+DB) 100-95% Testing Curve


PA Mode 100-95% Testing Curve






