- Correct the phone numbers for Houston office.

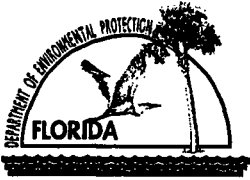


