  - a. 500 pounds per year or more of lead and lead compounds expressed as lead;**

**Based on the current Title V permit condition C.4., the particulate matter emission limitation from the lime silo baghouse is 0.021 tons/year, well below the 5 ton/year limitation referenced above and there are no other applicable requirements for this emission unit.**

**Therefore, Wheelabrator North Broward is requesting the facility Title V permit be revised to reclassify the lime silo baghouse as an insignificant emission unit and have all associated permit conditions removed.**

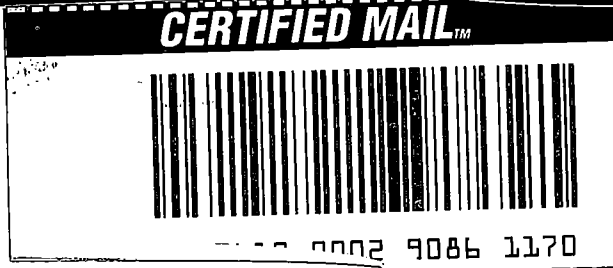
