Applicant: The applicant for this project is Progress Energy Florida. 100 Central Avenue. St. Petersburg. Florida 33701. The applicant's responsible official is Michael Olive, Plant Manager.

Facility Location: The applicant operates a power plant, which is located at 15760 West Power Line St., Crystal River in Citrus County, Florida.

**Project.** The applicant submitted an application for a 11the V Air Operation Permit. This permit will be a renewal of the air operating permit for this facility.

Permitting Authority: Applications for Title V air operation permits are subject to review in accordance with the provisions of Chapter 403, Roida Statutes (F.S.) and Chapters 62-4, 62-210, and 62-213 and 62-214 of the Florida Administrative Code (F.A.C.). The proposed project is not exempt from air permitting requirements and an air permit is required to operate the facility. The Florida Department of Environmental Protection Bureau of Air Regulation is the Permitting Authority responsible for making a permit determination regarding his project. The Permitting Authority's hysical address is: 111 S. Magnolia Avenue, Tatlahassee, Florida 32399. The Permitting Authority's mailing address is: 2600 Balatstone Rd., Mailstop #5505. Tallahassee, Florida 32399. The Permitting Authority's telephone number is 850/488-0114 and facsimile 850/922-6979.

Project File: A complete project file is available for public inspection, during the normal business hours of 8.00 a.m. to 5.00 p.th. Monday through Friday (except legal holicosy), of address indicated above the Permitting Authority. The complete project file includes the DRAFT Permit, the Statement of Bass, the application, and the information submitted by the applicant exclusive of confidential records under Section 403.111, F.S. Interested persons may view the DRAFT Permit and file electronic comments by visiting the following website:

Notice of Intent to Issue A Permit. The Permitting Authority gives notice of its Intent to issue a permit to the applicant for the project described above. The applicant has provided reasonable assurance that operation of the facility will not adversely Impact air quality and that the project will comply with all appropriate provisions of Chapters 62-4, 62-204, 62-210, 62-212, 62-213, 62-295, 62-295, 62-291, 62-292, and 62-297, F.A.C. The Permitting Authority will issue a PRO-POSED Permit and subsequent FINAL Permit in accordance with the conditions of the DRAFT Permit unless a response received in accordance with the following procedures results in a different decision or a significant change of terms or conditions.

Comments: The Permitting Authority will accept written comments concerning the DRAFT Permit for a period of thirty (30) days from the date of publication of this Public Notice. Written comments must be post-marked and all e-mail or facsimile comments must be received by the close of business (5 pm) on or before the end of this 30-day period by the Permitting Authority at the above address, email or facsimile. As part of his or her comments, any person-may also request that the Permitting Authority hold a bublic meeting on this permitting action. If the Permitting Authority determines there is sufficient interest for a public meeting, it will publish notice of the time, date, and location on the Department's official web site for notices at:

and in a newspaper of general circulation in the area affected by the permitting action. For additional information, contact the Permitting Authority at the above address or phone number. If written comments or comments received at a public meeting result in a significant change to the DRAFT Permit, the Permitting Authority snot issue a Revised DRAFT Permit and require, if applicable, another Public Notice. All comments filed will be made available for public inspection.

Petitions: A person whose substantial interests are affected by the proposed permitting decision may petition for an administrative hearling in accordance with sections, 120,569 and 120,57. F.S. The petition must contain the information set forth below and must be filled with (received by) the Department's Agency Clerk in the Office of General Coursel of the Department of Environmental Protection at 3900 Commonwealth Boulevard. Mail Station #35, Tallahassee, Florida 23399-3000. Petitions filled by any persons other than those entitled to written notice under Section 120,60(3), F.S. must be filled within fourteen (14) days of publication of this Public Notice or receipt of a written notice whichever occurs first. Under Section 120,60(3), F.S. however, any person who asked the Permitting Authority for notice of agency action may fille a petition within fourteen (14) days of receipt of that notice, regardess of the date of publication. A petitioner shall mail a copy of the petition to the applicant at the address indicated above, at the time of filing. The failure of any person to fille a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120,569 and 120,57; F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filling of a motion in compilance with Rule 28-106,205, F.A.C.

A petition that disputes the material facts on which the Permitting Authority's action is based must contain the following information: (a) The name and address of each agency affected and each agency's file or identification number. If known: (b) The name, address and telephone number of the petitioner: the name address and telephone number of the petitioner's representative. If any, which shall be the address for service purposes during the course of the proceeding; and an explanation of how the petitioner's substantial rights will be affected by the agency determination: (c) A statement of how and when the petitioner received notice of the agency action or proposed action; (d) A statement of all disputed issues of material fact, if there are none, the petition must so state; (e) A concise statement of the utilimate facts alleged, including the specific facts the petitioner contends warrant reversal or modification of the agency's proposed action; (f) A statement of the specific rules or stautres the petitioner contends require reversal or modification of the agency's proposed action; and (g) A statement of the eigency's proposed action; and the agency's proposed action the petitioner wishes the agency to take with respect to the agency's proposed action. A petition that does not dispute the material facts upon which the Permitting Authority's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as 'required by Rule 28-106.301, F.A.C.

Because the administrative hearing process is designed to formulate find agency action, the filing of a petition means that the Permitting Authority's final action may be different from the position token by it in this Public Notice of Intent. Persons whose substantial interests will be affected by any such final decision of the Permitting Authority on the application have the right to petition to become a party to the proceeding. In accordance with the requirements set forth above.

**Mediation:** Mediation is not available for this proceeding.

Objections: In addition to the above right to petition, pursuant to 42 United States Code (U.S.C.). Section 7661d(b)(2), any person may petition the Administrator of the EPA within skty (60) days of the expiration of the Administrator's 45 (forty-five) day review period as established at 42 U.S.C. Section 7661d(b)(1), to object to the issuance of any Ittle V air operation permit. Any petition shall be based only on objections to the Permit that were raised with reasonable specificity during the thirty (30) day public comment period provided in the Public Notice, unless the petitioner demonstrates to the Administrator of the EPA that it was impracticable to raise such objections within the comment period or unless the grounds for such objection arose after the comment period. Filling of a petition with the Administrator of the EPA does not stay the effective date of any permit properly issued pursuant to the provisions of chapter 62-213, FAC. Petitions filled with the Administrator of EPA must meet the requirements of 42 U.S.C. Section 7661d(b)(2) and must be filled with the Administrator of the EPA at: U.S. EPA, 401 M Street, S.W., Washington, D.C. 20460.
