Re: Revised permit for the Crystal River Power Plant

Dear Mr. Hatcher:

As you are aware, the Environmental Protection Agency has revised the 8-hour ozone standard. Based on the 2006 – 2008 ambient monitoring data, several counties near the Crystal River Power Plant are close to or exceeding the new ozone standard. In addition, the U.S. Court of Appeals for the District of Columbia has vacated the Clean Air Interstate Rule (CAIR) and it is unclear whether a rehearing will be requested or granted in that case. The Clean Air Act clearly requires states to address the interstate transport of pollutants and, to the extent vacature of CAIR is not reversed, Florida is under an obligation to address interstate transport.

In light of the foregoing and the Department's authority under Rule 62-4.080, Florida Administrative Code, the Department intends to revise the air construction permit for the Crystal River Power Plant to require the operation of the scrubber and selective catalytic reduction system.

Please submit relevant emissions information and applications to modify the air construction permit for this facility to the Department as soon as possible. If you have any questions regarding this matter, please call me or Trina Vielhauer of my staff at (850) 488-0114.
