FINAL ORDER

On October 16, 1992, the Florida Department of Environmental Regulation (Department) received a Petition for Administrative Proceeding from Petitioner, Florida Solite Company. The Petition challenged specific conditions in the Department's intent to issue Permit No. A010-216998 for the operation of Kiln No. 1, a lightweight Aggregate Kiln, in Clay County.




