Waiver Of Permit Application Processing Time Periods

Dear Mr. Linero:

As the Responsible Official for the Dade County Resources Recovery Facility, and a representative of the facility operator (Montenay Power Corporation) I request that the Florida Department of Environmental Protection waive the permit application processing time for sections of the Title V and Construction permit application changes related to changes in carbon monoxide limits for the four municipal solid waste combustion units at the facility. A form with the request is attached.

This request is made since the State has not yet adopted the 250 ppm limit for carbon monoxide that was set forth in the May 2006 changes for the Emission Guidelines of 40 CFR 60 Subpart Cb. As such, we are requesting that FDEP delay acting on this specific request until August 2007 at the latest, by which time we hope that FDEP will have adopted the Emission Guideline, or the Department will have provided other mechanisms for implementing the Emission Guideline changes.

This waiver does not apply to any other information or requests for changes in the permit application, and we respectfully request that the Department proceed with processing the rest of the permit according to any requirements or applicable deadline.

Please advise us if any other actions are required to complete this request.
