Dear Messrs. Morello and Casey:

Thank you for your response received on September 11, 2006, to our request for additional information concerning the subject permit applications. However, we must deem your applications still *incomplete*, because we need further clarification relative to the following items:

1. Carbon Monoxide Limit: On page 3 of your response, in assessing the impact of raising the CO limit to 250 ppm, you report a net potential emissions increase (future actual – past actual) of 19.0 tons per year (TPY) in the body of the paragraph, but 41.0 TPY in the table that follows. Please indicate which number is correct. Also, please provide all computations used in the development of the table values.
2. Responsible Official for Landfill: On page 9 of your response you indicate that a different responsible official (other than the current facility responsible official) will oversee the landfill (ash monofill) at the site. It is unclear as to what the chain of command responsibilities will be under this new arrangement. We note that the only sections in the current Title V permit that mention the landfill are (1) the Facility Description, (2) the specific condition addressing Emissions of Unconfined Particulate Matter, and the List of Insignificant Emissions Units and/or Activities. Will the County designate a Primary Responsible Office for the total facility, with additional Responsible Officials designated for the Resource Recovery Facility and the landfill respectively? It appears that your application for an air construction permit to effect this change is not appropriate. The proper vehicle is the submission of Responsible Official Notification Form available at the Department's web site.

When we receive this information, we will continue processing your application. If you have any questions, please contact Project Engineer Tom Cascio at 850-921-9526. Rule 62-4.050(3), F.A.C. requires that all applications for a Department permit must be certified by a professional engineer registered in the State of Florida. This requirement also applies to


