
**SOURCE INFORMATION:**

The facility is an existing major source of Hexane Emissions subject to the NESHAP for rubber tire manufacturing, with a compliance date of July 11, 2005. Operations at the facility consist of rubber tire retreading operations.

Please note that the facility is currently considering process changes that may be implemented by December 31, 2002. The process changes being considered include the replacement of hexane by heptane. If the change is accomplished as proposed, the facility will no longer be a major source of Hazardous Air Pollutant (HAP) Emissions, and therefore not subject to the National Emissions Standards for Hazardous Air Pollutants: Rubber Tire Manufacturing Subpart of 40 CFR Part 63.
