REQUEST FOR ENLARGEMENT OF TIME

- 1. On or about June 3, 2002, DeSoto received from the Department of Environmental Protection ("Department") an "Intent to Issue Title V Air Operation Permit" (Draft Permit No. 0270016-003-AV) for the DeSoto County Generating Company, located in DeSoto County, Florida. Along with the Intent to Issue, DeSoto received a Draft Title V permit and "Public Notice of Intent to Issue Title V Air Operation Permit."
- 2. Based on DeSoto's initial review, the Draft Permit and associated documents contain several provisions that warrant clarification or corrections.
