Re: Request to Use Fuel Additives in the Nos. 1 and 2 Circulating Fluidized Bed Boilers
Northside Generating Station
Permit Project No.: 0310045-023-AC/PSD-FL-265F

Dear Mr. Chansler:

The Department has received the request to use fuel additives in the Nos. 1 and 2 Circulating Fluidized Bed Boilers located at the JEA's Northside Generating Station. The P.E. Seal page was received on September 16, 2008. A site visit was conducted on September 24, 2008, with Mr. Bert Gianazza (JEA) and Mr. Richard Robinson (Duval County) to discuss the current proposal. Based on our initial review of the proposed project, we have determined that additional information is needed in order to continue processing the request. Please provide all assumptions, calculations, and reference material(s), that are used or reflected in any of your responses to the following issues:

1. Describe how the facility will receive the proposed fuel additive materials, unload the materials, store the materials, and use the materials. Include in the description, among other things, the transportation units, storage facilities, wind breakers and dust suppressants. Also, describe a full cycle of operation with the fuel additives that covers the time from the receipt of the fuel additives through the final usage of these materials. Also, provide the potential source of the fuel additives and include an analysis of these materials.
2. How much of each material will be utilized hourly and annually. Provide the calculations and submit the potential to emit (PTE) for the pollutants that are expected to be generated with the receiving, storage, and processing of the fuel additives, specifically kaolinite (clays) and bottom ash. Based on the site visit, it appears that all of the PTE are fugitive emissions of particulate matter.
3. Provide a plot map for the proposed locations of the proposed Quonset huts and wind breakers. How many Quonset huts will be utilized.
4. After completing the calculations for the PTE, provide a rule applicability analysis for the proposed activity. If appropriate, complete the application pages for an air construction permit in Form 62-210.900(1), Florida Administrative Code, and submit.
