

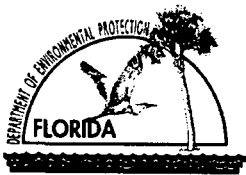
The former Responsible Official on record for this facility, Del Brooks, retired effective December 31, 2007 and I have succeeded him as General Manager of this facility.

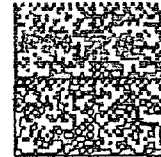
