WITHDRAWAL OF REQUEST FOR EXTENSION OF TIME

By and through undersigned counsel, JEA hereby withdraws its Request for Extension of Time to file a Petition for Administrative Proceedings in accordance with Florida Administrative Code Rule 62-110.106(4). On January 5, 2009 JEA requested an extension of time until March 6, 2009, within which to file a Petition for Administrative Hearing with regard to the Revised Technical Evaluation and Preliminary Determination, Revised Proposed Draft Air Permit, and Revised Written Notice of Intent to Issue Air Permit (Permit No. PSD-FL-401, 0310561-001-AC) received on December 22, 2008. The Department of Environmental Protection (Department) granted that extension on January 12, 2009.

This withdrawal is conditioned upon changes agreed to between the Department and JEA, which are reflected in the revised draft final determination attached as Exhibit A.
