Re: Approval of Compliance Deadline Extension Request for Plant Kraft Units 1, 2, 3 and 4 Mercury and Air Toxics Standards (MATS) Rule, Title 40 CFR Part 63, Subpart UUUUU

Dear Mr. Mitchell:

On April 24, 2013, the Division received a written request from your Company (dated April 23, 2013) for an extension of the April 16, 2015 compliance deadline for 40 CFR Part 63 Subpart UUUUU, National Emission Standard for Hazardous Air Pollutants (NESHAP) for Mercury and Air Toxics Standards (MATS) from Coal- and Oil-Fired Electric Utility Steam Generating Units for Units 1, 2, 3 and 4 located at Plant Kraft. Georgia has adopted and incorporated by reference the regulation into the Georgia Rules for Air Quality Control effective August 1, 2013.

Title 40 CFR 63.6(i)(4)(i)(A) allows the owner or operator of an existing source who is unable to comply with a relevant standard established under this part pursuant to Section 112(d) of the Act request an extension allowing the source up to one additional year to comply with the standard, if such additional period is necessary for the installation of controls.

Based on the information provided in your request under paragraph (i)(4), the Division has evaluated the information and determined that it is appropriate to grant a one-year compliance extension for the applicable requirements of the Rule. Approval of your request for an extension of the compliance deadline shall include the following: [40 CFR 63.6(i)(10)]:

- i. Identify each affected source covered by the extension;*
Georgia Power Plant Kraft Units 1, 2, 3 and 4.
- ii. Specify the termination date of the extension;*
The compliance deadline for meeting the emissions limits contained in the MATS Rule shall be on or before April 16, 2016.
- iii. Specify the dates by which steps toward compliance are to be taken;*
Georgia Power Plant Kraft shall make every attempt to adhere to the compliance schedule contained in the extension request dated April 23, 2013.



- iv. *Specify other applicable requirements to which the compliance extension applies;*
The deadline extension also applies to the initial performance test demonstrating compliance with the MATS Rule emission limits. The initial performance test shall be conducted within 180 days of April 16, 2016.
- v. *Specify any additional conditions that the State deems necessary to assure installation of the necessary controls and protection of the health of persons during the extension period or; specify and additional conditions that the Administrator deems necessary to assure the proper operation and maintenance of the installed controls during the extension period.*

Within 60 days of receipt of this letter, the Company shall submit a Part 70 Permit Application to the Division to amend the permit to incorporate the MATS Rule compliance extension.


