SETTLEMENT STIPULATION

Petitioner ADAGE Hamilton LLC (ADAGE) and Respondent Department of
Environmental Protection (Department), by and through their undersigned counsel, stipulate to
the settlement of this case, and in support thereof, state:

- 1. On October 8, 2009, the Department issued its notice of intent to issue a draft air construction permit, Permit No. 0470016-001-AC, to ADAGE for it to construct a woody biomass power plant in Hamilton County, Florida.
- 2. On October 21, 2009, the Department received a timely request for an extension of time to file a petition for formal administrative hearing concerning the draft permit from ADAGE, which the Department granted though November 24, 2009. During this time extension, ADAGE proposed changes to the draft permit for the Department's consideration. Before the parties could reach resolution of the proposed changes to the draft permit, ADAGE's extension ran. On November 23, 2009, ADAGE filed a timely second request for extension of time to file a petition for formal administrative hearing, which the Department granted through December 23, 2009.

- 3. Having now come to a resolution of the changes ADAGE proposed, the Department within seven (7) days of this Settlement Stipulation being signed by all parties, will withdraw the intended draft permit issued on October 8, 2009, and will issue the revised draft permit, attached hereto and incorporated herein as Attachment A (the Revised Permit). The Revised Permit will become the final permit without any changes unless a petition is timely filed by a person (who has standing and who is granted party status) not party to this Settlement Stipulation which results in litigation that causes changes to the Revised Permit.
- 4. ADAGE agrees to waive its right to petition for an administrative hearing under Chapter 120, Florida Statutes, and its right to submit written comments regarding the Department's issuance of the Revised Permit, unless there are any changes made to the Revised Permit that are not reflected in Attachment A. The parties agree that ADAGE would be a necessary party to any litigation resulting from a petition being filed by any other person regarding the issuance of the Revised Permit.
- 5. ADAGE agrees to publish notice of the Revised Permit in accordance with Rule 62-210.350, Florida Administrative Code, within fourteen (14) days of receipt of the Department's notice of intent to issue the Revised Permit, and will submit proof of publication to the Department promptly thereafter. The notice language, as agreed to between ADAGE and the Department, is included as Attachment B.
- 6. ADAGE hereby withdraws its November 23, 2009, request for extension of time to file a petition for formal administrative hearing.
- 7. Each party shall be responsible for its own costs and attorney's fees and waives any right that it may have against any other party for costs and attorney's fees associated with this action.

8. All parties acknowledge that they have the right to seek judicial review under Section 120.68, Florida Statues, by filing a notice of appeal under Rules 9.110 and 9.190, Florida Rules of Appellate Procedure. By executing this Settlement Stipulation, each party waives its right to such appeal and to any further notice of that right.



As good cause for granting this request, ADAGE states the following:

- On or about October 8, 2009, ADAGE received from the Department of
 Environmental Protection (Department) a Draft Air Permit, a Technical Evaluation and Preliminary
 Determination, and a Written Notice of Intent to Issue Air Permit (Permit No. 0470016-001-AC)
 for a woody biomass power plant to be located in Hamilton County, Florida.
- 2. The Draft Air Permit and the Technical Evaluation and Preliminary Determination contain several provisions that warrant clarification, correction, or revision.
- 3. Representatives of ADAGE have corresponded and will continue to correspond with staff of the Department's Bureau of Air Regulation in an effort to resolve all issues.
