Seminole Electric Cooperative, Inc. (SECI) is planning to construct and operate ten (10) simple cycle combustion turbines (CTs) at its existing Payne Creek Generating Station. The Payne Creek Generating Station is located approximately 9 miles northwest of the City of Wauchula at 6697 County Road 663, Bowling Green, Hardee County, Florida.
