Ronni – Thank you for your continued help with this matter. I've attached a slightly revised version of the draft settlement agreement for your review and consideration. I changed "stalk fiber" to "bagasse and wood" as the fuels for the boiler, consistent with our discussions on Monday. We understand that we may receive the revised draft permit language later this morning. On the notice, we have only a few minor suggested changes: (1) current address for the company should be used; (2) "leftover stalk fiber (bagasse)" should be changed to "bagasse"; (3) "sweet sorghum molasses" should be changed to "sweet sorghum syrup and molasses"; and (4) in the fifth paragraph, "stoker" is misspelled as "stocker." Lastly, we wanted to confirm that the HCl CEMS is not being required and it could therefore be deleted from the notice as well. The notice was sent in a PDF format, so I wasn't able to revise the notice language directly. If you could send it to me in word, I can make these changes, or you could ask your assistant to make the changes and send us the new version. Also, because we didn't have the details worked out yesterday, we missed the Sunday publication. If we can get the notice to the paper today, however, it will be published next Thursday, the 25th.

Even though it is Thanksgiving day, the paper will be published. So, we appreciate your continued help with this. If you have any questions or would like to discuss, please let me know. Best regards, Angela

Ronni – we are making the finishing touches on the permit language and hope to get it to the Department very soon (before noon). In the meantime, I wanted to let you know what we learned about the newspaper publications. There are two papers – one publishes on Thursdays and one on Sunday.

Deadline of Nov. 18 for publication on Nov. 21st – possible if we can get closure tomorrow (or enough closure that we can send it for publication knowing we could get the package on Friday – before the paper is received by everyone on Sunday).

Deadline of Nov. 22nd. For publication on Nov. 25th (Thanksgiving Day – so we are confirming).

Deadline of Nov. 25th for publication on Nov. 28th (deadline is Thanksgiving day – so we are confirming).

Deadline of Nov. 29th for publication on December 2nd (missing ability to have the permit issued by the end of the year).

If you have the new notice language ready, please let us know and we can forward it to the paper.
