Susan,

In my emails I am not finding the information at this point but for expediency, we discussed the matter on April 14 at 2 to 3 pm. I can summarize the request in this email:

Cemex Brooksville South cement plant is allowed under a air permit (0530021-35-AC) to temporarily trial burn specific alternative fuel materials. The air permit allows grinding, if needed, of materials

for the temporary injection system. As we discussed on April 14, Cemex requested from the Solid Waste section of FDEP to ensure the temporary grinding of materials allowed under the air permit would not require solid waste permitting. When the trials were complete Cemex would request Solid Waste permitting, if needed, to grind materials on a permanent basis. As well, when the trials were to be underway, Cemex would submit to Solid waste updates of any grinding activities.

To date, Cemex has trial burned peanut hulls and tire-derived fuel which has not required any on-site grinding.

As my my most recent request states that Cemex is requesting for conducting such grinding at the Cemex Brooksville North cement plant. That plant has the enclosed space and plenty of room under cover to conduct any such grinding.

Please let me know what information you need to address this request.

Dear Susan,

In follow up to our phone conversation today, I am requesting a similar approval that we (Chris McGuire, George Townsend (Cemex), Richard Tedder, you and I) discussed by phone conference a couple of months ago. As you recall, the Cemex Brooksville south cement plant is in the process of trial testing alternative fuels in the Kiln 2 system. The trial is described in the attached air permit. The air permit allows grinding of materials. As such, we discussed on the phone that the temporary nature of the trials was such that the materials would not require full solid waste permitting at this time, and until Cemex determines what fuels are viable the temporary project would be exempt from permitting.

In review of the request, Cemex would like to request that this grinding be allowed also at the Cemex Brooksville North cement plant location. As you know, this plant has not operated for several years and the amount of truck and operational activity is limited, which is one reason to request grinding at the North plant. As well, the location is to be conducted totally within the cement packing building which I have attached a overview image (with circle of the building) and interior images.

Clearly, storing and grinding marterials for this temporary trial at this location is well isolated from potential environmental exposure. As such, we view this location to be an excellent location to temporarily grind materials.

As we discussed on the phone, please send me a response to this request at your earliest convenience.
