**ORDER DENYING REQUESTS FOR EXTENSION OF TIME TO FILE A SECTION 120.57(1),
FLORIDA STATUTES, PETITION FOR FORMAL ADMINISTRATIVE PROCEEDINGS
AND PETITIONS FOR FORMAL ADMINISTRATIVE HEARING**

On May 6, 2005, the Department of Environmental Protection (Department) received a request for an extension of time to file a Section 120.57(1), Florida Statutes, Petition for Formal Administrative Proceedings from the Petitioner, Florida Crushed Stone Company. The request for an extension of time cites to Rule 62-110.106(4), F.A.C., as authorization for the request. The request for an extension of time alleges that on April 15, 2005, the Petitioner submitted to the Department a request for confirmation that the August 2004 compliance test at its Brooksville Cement Plant of Dioxin/Furan emissions was properly noticed and performed in accordance with permit requirements. The request for an extension of time alleges that on April 25, 2005, the Petitioner received an e-mail, which the Petitioner contends reflects the Department's "determination to reject Florida Crushed Stone's August of 2004 compliance test of Dioxin/Furan emissions." This initial request sought an extension of time through June 20, 2005, so that the parties could meet to discuss the issues. A meeting was held but no resolution has yet been reached. On June 20, 2005, the Department received a second request

for an extension of time. The Petitioner seeks a further extension until July 20, 2005, to file a petition for formal administrative hearing to challenge whether the August 2004 compliance test was properly noticed and performed pursuant to 40 CFR 63, Subpart LLL.

Under Section 120.57, Florida Statutes, a party may petition for an administrative evidentiary hearing to contest any proposed final agency action where the proposed final agency action would determine that party's substantial interests and where there is a disputed issue of material fact that formed a basis for the proposed final agency action. The burden is on the Petitioner to demonstrate that the Department has taken final agency action that affects the Petitioner's substantial interests. The e-mail attached to the request for an extension of time is not an agency action as defined in Section 120.52(2), F.S., and is not subject to review under the Administrative Procedures Act. The e-mail is neither a rule nor an order, nor does Petitioner allege that it is of such a character. The e-mail does not, in and of itself, appear to affect the Petitioner's substantial interests. The e-mail attached to the request for an extension of time appears to reflect nothing more than preliminary, non-final agency action.

Based on the foregoing

IT IS ORDERED:

- A. The requests for an extension of time are DENIED.
- B. Petitioner requests that, should its request for extension of time be denied, the Department consider the pleadings to be Petitions for Formal Administrative Hearing. To the extent that the Requests for Extension are considered to be Petitions for Formal Administrative Hearing, they are insufficient, and are also DENIED.
- C. The Petitioner is allowed **fourteen (14)** days from the date set forth in the certificate of service on the last page of this order within which to file a petition for a Section 120.57(1), Florida Statutes, formal administrative proceeding. The petition must be filed (received) in the Office of General Counsel, Department of Environmental Protection, 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000, by 5:00 p.m.

The petition for administrative hearing must contain the following information:

(a) The Petitioner's name, address, and telephone number; the Department case identification number and the county in which the subject matter or activity is located;

(b) A statement of the specific facts which demonstrate that the Department has taken final agency action subject to review under Chapter 120, Florida Statutes.

(c) A statement of how and when the Petitioner received notice of the alleged final agency action;

(d) A statement of how each petitioner's substantial interests are affected by the alleged final agency action;

(e) A statement of the material facts disputed by the Petitioner;

(f) A statement of facts that the Petitioner contends warrant reversal or modification of the alleged final agency action;

(g) A statement of which rules or statutes the Petitioner contends require reversal or modification of the alleged final agency action; and

(h) A statement of the relief sought by the Petitioner, stating precisely the action that the Petitioner wants the Department to take.

D. Nothing herein precludes Petitioner from timely requesting an administrative hearing at such time as the Department takes Final Agency Action with respect to any asserted permit non-compliance issues.

E. This order constitutes final agency action of the Department unless a timely amended petition is filed in conformance with this order.

Any party to this order has the right to seek judicial review of the order under section 120.68 of the Florida Statutes by the filing of a notice of appeal under rule 9.110 of the Florida Rules of Appellate Procedure with the clerk of the Department in the Office of General Counsel, 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000, and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate

district court of appeal. The notice of appeal must be filed within thirty days after the date this order is filed with the clerk of the Department.

This request for confirmation noted in detail the chronology of the testing notifications and communications between Florida Crushed Stone and the Florida Department of Environmental Protection ("Department"), and included copies of letters and emails.

In response, on or about Monday, April 25, the Department made its determination to reject Florida Crushed Stone's August of 2004 compliance test of Dioxin/Furan emissions performed pursuant to 40 CFR 63, Subpart LLL. The permittee, through its agent, John Koogler, Ph.D., P.E., received the Department's determination by email on Monday, April 25, 2005, see attached.

Extensions of time in which to file Petitions for Hearing are allowed under Chapter 120, Florida Statutes, and Rules 28-106.111(3) and 62-110.106(4), Florida Administrative Code. This request for a further extension of time is timely filed within the time period previously sought by permittee's May 6, 2005, extension request.

Subsequent to permittee's May 6, 2005, request for extension of time to file a petition, the applicant and the Department engaged in discussions and meetings regarding air compliance issues, including a meeting on May 31, 2005, in Tallahassee with the Tallahassee FDEP Bureau of Air Resources and the Tampa FDEP District staff. Later, on June 10, 2005, the applicant's agent, John Koogler, Ph.D., P.E. wrote the Department and provided a proposal to resolve all remaining issues. However, as of the date of this request, no response or acknowledgment from the Department has been received, either verbally or in writing. As such, and in an abundance of caution, the applicant seeks a further thirty (30) day extension of time in order to meet with the Department to review and resolve any issues related to the August 2004 compliance test.


