Request for Authorization to Install TIMS Mounting Frame at the front end of Kiln No. 1

Dear Mr. Townsend:

On October 31, 2008, the Department received your request by electronic mail for authorization to install a portion of the requested tire injection mechanism system (TIMS) project during the upcoming kiln outage from November 3-12, 2008. The original request for the TIMS project was received on August 7, 2008. The Department is denying the request for installing the mounting frame during the current kiln outage for the following reasons:

1. Approval of the request would represent a violation of the commence construction rule in Rule 210.200(88), Florida Administrative Code (F.A.C.), which is shown below.

88) "Commence Construction" – As applied to the construction or modification of a facility, means that the owner has all preconstruction permits and approvals required under federal air pollution control laws and regulations and those air pollution control laws and regulations which are part of the State Implementation Plan (SIP) or which are part of Chapter 62-210 or 62-212, F.A.C., to the extent that the provisions of these laws and regulations specify conditions or requirements for obtaining a state construction permit for an emissions unit, and:


- (a) Begins a continuous program of actual on-site construction or physical modification of the facility, to be completed within a time commensurate with the nature of the construction project; or
- (b) Enters into binding agreements or contractual obligations, which cannot be cancelled or modified without substantial loss to the owner or operator, to undertake a program of actual construction or physical modification of the facility to be completed within a time commensurate with the nature of the construction project; or
- (c) Begins those on-site activities, other than preparatory activities, which mark the initiation of a change in the method of operation of the facility.

2. In addition, the Department issued a request for additional information (RAI) on September 2, 2008. The response to our RAI was received on November 3, 2008. If the Department had received this response earlier, there would have been sufficient time for the Department to review the response and make a determination on the TIMS project.
