D. SOURCE DESCRIPTION

- 1) DESCRIPTION OF MAJOR SOURCE: Sebring Power (Dinner Lake Station) is a nominal 12.65 MW electric generation facility. The facility consists of a steam boiler; steam turbine; once through cooling water system; fuel storage tanks; and ancillary support equipment. The steam boiler is fired with pipeline natural gas as its primary fuel source. Supplemental fuel sources include propane, No.6 fuel oil and used oil. The Dinner Lake Station is presently operated in a cold standby mode. Title V Permit No. 0550004-001-AV states that based on the initial Title V permit application received by FDEP on June 14, 1996, this facility is a major source of hazardous air pollutants (HAPs).
