In response to your letter dated November 6, 1992 we request that the expiration date of Permit No. AC29-196763 be extended to June 30, 1993. This extension is needed to provide us with time to complete an engineering evaluation of the system and determine the modifications required to be able to operate at the rates anticipated in the original construction permit application. We recognize that the expected changes will require that the construction permit be modified. Therefore, we propose that the amended permit require that a modification application or operating permit application be submitted at least 90 days prior to expiration of the permit (i.e., submitted by April 1, 1993).

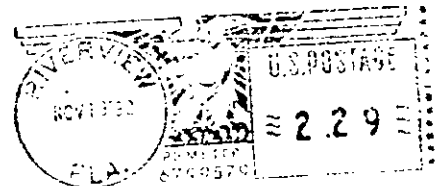

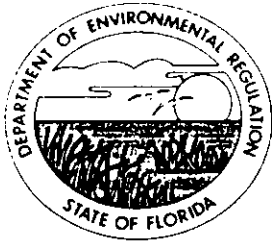

The Department received Cargill's \$50.00 check which initiated processing of your request for an 18-month extension of time to install a new granulator and associated equipment.

Since it is evident that additional equipment will be installed that is beyond the scope of work contemplated in the November 26, 1992, PSD permit, Cargill will have to submit a minor modification application to the District office describing all equipment to be installed (\$250 fee). Since PSD-FL-178 expires on December 31, 1992, we will extend the construction permit through June 30, 1993, to allow time to obtain the modification permit from the District office.
