Dear Ms. Vielhauer:

By letter dated December 17, 2007, Mosaic explained that it was operating under the authority of its existing construction permits (referenced above), based on Rule 62-213.420(1)(b), Fla. Admin. Code, since its application for a Title V permit revision was timely and complete before the construction permits expired. Nonetheless, to avoid any concerns, Mosaic also requested that the expiration dates for these permits be formally extended.

Because it was unnecessary, and to avoid any further confusion, Mosaic hereby withdraws its December 17 request for an extension of the above-referenced construction permits, and will continue operating under the authority of these permits based on Rule 62-213.420(1)(b), Fla. Admin. Code., until the conclusion of the proceedings on the Title V permit revision.
