Re: Modification of Permit No. AC 29-122068

The Bureau has read your June 1, 1989, letter to the Environmental Protection Commission of Hillsborough County responding to our May 18, 1989, letter to you and your September 20, 1989, letter to the Department.

We have again reviewed our file of permit no. AC 29-122068. The affected sources (dust collector numbers 27, 28, 42, 43, 44, 45, and 50) were allowed to emit 12.48 TPY particulate matter. We confirm the statement in your March 14, 1989, letter that the emissions in TPY for the unloading system will be correspondingly higher (increase from 12.48 TPY to 18.66 TPY) if the requested changes are made.

A change that results in an increase in emissions is a modification that requires a permit to construct. The changes you requested will result in an increase in emissions for dust collectors Nos. 28, 42, 43, 44 and 45. This will require a new construction permit. The emissions from the modified sources would have to comply with the state regulation and meet, at least, the particulate matter RACT standard of 0.03 gr/dscf for particulate matter.

If you still wish to pursue the modification, please submit an application for permit to construct that shows all changes being requested to permit No. AC 29-122068.
