Dear Mr. Pretat:

Re: Modification of Permit No. AC 29-122068

The Bureau of Air Quality Management has reviewed your March 14, 1989, letter requesting the referenced permit be changed to allow the vacuum type ship unloading system more hours/year of operation at a reduced unloading rate. This will result in an increase in particulate matter (PM) emissions. Regulations will not allow the Department to grant your request by amending the referenced permit.

The referenced permit expired on December 31, 1988. Permitted PM emissions from the point sources listed in your letter would increase from 12.5 TPY to 18.7 TPY. The emissions you are requesting would increase the net contemporaneous PM emissions by 6.2 TPY. An increase in emissions is defined as a modification by the state's regulations, and a modification requires a new permit to construct.

For the reasons stated above, the Bureau cannot recommend your request be approved. If you wish to pursue the modification, please submit a new application for permit to construct that shows the changes being requested will comply with the air pollution control regulations for PM and PM₁₀.


