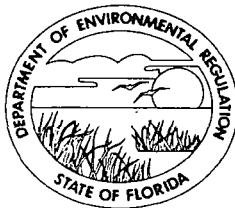

Expiration Date Change:




