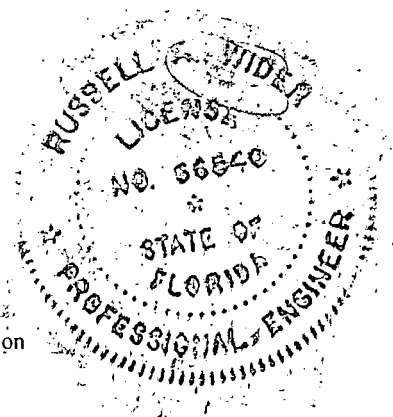
The purpose of this project is to reissue air construction permit 0570039-031-AC, which specifically: (1) extended the air construction permit expiration date from December 31, 2007 to March 31, 2008 for Unit No. 4, and (2) authorized the construction work for duct work separation as part of a scrubber tower separation initiative. The current air construction permit for Unit No. 4 has expired and the applicant has requested the re-issuance of Air construction permit 0570039-031 with a new expiration date of December 31, 2008. Construction for the duct work separation is complete, thus new construction has not been authorized by this permitting action. Tampa Electric Company shall submit the Big Bend Title V permit renewal application incorporating this project and all other applicable projects by June 6, 2008, approximately six months prior to the current Big Bend Station Title V permit renewal application due date.

On April 2, 2008, you submitted an application requesting that the Department reissue air construction permit 0570039-031-AC, which specifically: (1) extended the air construction permit expiration date from December 31, 2007 to March 31, 2008 for Unit No. 4, and (2) authorized the construction work for duct work separation as part of a scrubber tower separation initiative. The current air construction permit for Unit No. 4 has expired and the applicant has requested the re-issuance of air construction permit no. 0570039-031 with a new expiration date of December 31, 2008. This facility is located in Hillsborough County at Big Bend Road, North Ruskin, Florida. Enclosed are the following documents:



This facility is an electric utility. This air construction permit will affect Steam Generator No. 4. Big Bend Station is located at Wyandotte Road between Apollo Beach and North Ruskin, Hillsborough County. This site is in an area that is in attainment (or designated as unclassifiable) for all air pollutants subject to a National Ambient Air Quality Standard (NAAQS).

Project Description

This project is a re-issuance of air construction permit No. 0570039-031. The applicant has requested an extension of the expiration date to December 31, 2008 in order to accommodate the applicant's request to submit one Title V permit renewal application rather than incorporating numerous projects into multiple Title V permit revisions. The purpose of air construction permit no. 0570039-031 was to make some minor modifications to air construction permit No. 0570039-020-AC that authorized the installation of a selective catalytic reduction (SCR) system for nitrogen oxides (NO_x) control on the facility's Unit No. 4 coal-fired boiler. This Air Construction Permit Modification (0570039-031-AC): (1) extended the air construction permit expiration date from December 31, 2007 to March 31, 2008, and (2) authorized the construction work for duct work separation as part of a scrubber tower separation initiative. The current air construction permit for Unit

No. 4 has expired. Therefore, the changes requested will be addressed as an Air Construction Permit Re-issuance. Construction of this project is complete. 

As a consequence, the towers will also be split and the duct work configured, dedicating a stack to each unit. [Rule 62-4.070(3), F.A.C.]

A.14.2. Future Actual Emissions Reporting. The permittee shall maintain and submit to the Department on an annual basis for a period of 5 years from the date the duct work separation initiative is placed in operation, information demonstrating in accordance with Rule 62-212.300(1)(e), F.A.C., using the emissions computation and reporting procedures in Rule 62-210.370, F.A.C., that the implementation of the initiative did not result in an emissions increase of SO₂ that would equal or exceed the respective significant emission rate as defined in Rule 62-210.200, F.A.C. [Rule 62-212.300(1)(e), F.A.C.]



The Florida Department of Environmental Protection ("the Department") issued an air construction permit to Tampa Electric Company (TEC) authorizing the installation of a selective catalytic reduction (SCR) nitrogen oxides (NO_x) emission control system at Big Bend Station Unit 4; reference Air Construction Permit 0570039-020-AC dated May 6, 2005 with an expiration date of December 31, 2007. The Department subsequently modified this air construction permit authorizing ductwork revisions for Units 3 and 4 (duct split project), as well as extending the permit expiration date to March 31, 2008; reference Air Construction Permit 0570039-031-AC dated November 19, 2007.

A petition that does not dispute the material facts upon which the Permitting Authority's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301, F.A.C. Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the Permitting Authority's final action may be different from the position taken by it in this Public Notice of Intent to Issue Air Permit. Persons whose substantial interests will be affected by any such final decision of the Permitting Authority on the application have the right to petition to become a party to the proceeding, in accordance with the requirements set forth above.
