
RE: Lake Cogeneration L.P., Facility ID No. 0694801: Request to Withdraw
Permit Modification in Permit Renewal Application

Pursuant to this facility's November 6, 2007 submittal to the FLDEP, for renewal of its Title V permit, and the Department's subsequent letter of January 23, 2007, we hereby ask that the Department modify/ amend the permit renewal application by deleting Lake Cogen's request under LC-FI-E5: Changes to current permit, where it was requested that monitoring for mercury, lead, beryllium and sulfuric acid mist be removed as a permit condition.

This request is made so that the permit renewal process can continue in a smooth and expedited manner. Since the subject condition is already incorporated in the annual operating report prepared and submitted to the Department by Lake Cogen, this change to the renewal application will not impact existing operations or permit requirements.

Your application for this project has been received and reviewed for completeness. The following items are needed to complete your title V renewal application.

1. "LC-FI-E5: Changes to Current Permit" has a request to remove monitoring for mercury, lead, beryllium, and sulfuric acid mist. It is my understanding that a construction permit change is required to make the change enforceable. The DARM office in Tally will need to make the permit change.
2. As The DARM office has an application from your company, perhaps they can process the above requested change and renew the title V permit as requested in your construction permit application. I am copying them with this letter and perhaps they will accept this unique request under More Protection, Less Process theme.

Pursuant to Rule 62-4.055, the applicant shall have ninety days after the Department mails a timely request for additional information to submit that information to the Department. If an applicant requires more than ninety days in which to respond to a request for additional information, the applicant may notify the Department in writing of the circumstances, at which time the application shall be held in active status for one additional period of up to ninety days. Additional extensions shall be granted for good cause shown by the applicant. A showing that the applicant is making a diligent effort to obtain the requested additional information shall constitute good cause. Failure of an applicant to provide the timely requested information by the applicable deadline shall result in denial of the application.
