The designated "Responsible Official" is hereby authorized to act on behalf of Florida Power & Light Company on all Title V permit related activities for the assigned plant.

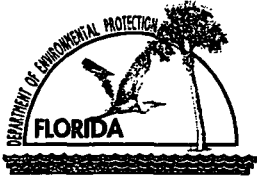
