The renewal application was received via Electronic Permit Submittal and Processing System (EPSAP). The applicant also requested the concurrent processing of an air construction permit revision to change miscellaneous underlying air construction (AC)/PSD permit conditions. The applicant certified compliance in the Title V air operation permit renewal application. Review of the Department's Air Compliance and Enforcement Search (ACES) on October 18, 2011 indicates that the facility is in compliance.

We issued (clerked) a draft/proposed Title V air operation permit renewal on March 18, 2011; the applicant never published the public notice. On May 24, 2011, we received about 12 pages of comments from the applicant which resulted in substantial changes to the draft/proposed Title V air operation permit renewal. Some of the requested changes required changes to underlying AC/PSD

permit conditions. The applicant subsequently applied on July 22, 2011 for the AC/PSD permit revision. To my knowledge these permits contain appropriate changes to either the applicant's satisfaction or to their understanding. This Title V air operation permit renewal application therefore in my opinion is not controversial and is routine. I do not anticipate any more significant comments. Parallel (combined), e.g., draft/proposed, processing is recommended.

This permit contains versions of the recently developed engine templates in Florida.

I recommend approval of the permits.
