If USEPA has an objection to the PROPOSED permit, the FINAL permit will not be issued until the permitting authority receives written notice that the objection is resolved or withdrawn.

I. Public Notice.

An "INTENT TO CONCURRENTLY ISSUE AN AIR CONSTRUCTION PERMIT & TITLE V AIR OPERATION PERMIT REVISION" to the City of Tallahassee for the Arvah B. Hopkins Generating Station located at 1125 Geddie Road, Tallahassee, Leon County, was clerked on December 7, 2006. The "PUBLIC NOTICE OF INTENT TO ISSUE A TITLE V AIR OPERATION PERMIT RENEWAL" was published in The Tallahassee Democrat on January 7, 2007. The DRAFT Title V Air Operation Permit was available for public inspection at the permitting authority's office in Tallahassee and the Department's Northwest District office in Pensacola. Proof of publication of the "PUBLIC NOTICE OF INTENT TO ISSUE A TITLE V AIR OPERATION PERMIT RENEWAL" was received on January 11, 2007.

No comments were received by the Department from the public or the applicant in response to the Draft Permit and Public Notice.
