Requested Amendment to Air Permit No. 0730003-009-AC

Arvah B. Hopkins Generating Station

Unit 2 Re-Powering Project

Dear Mr. McGarrah:

Thank you for your letter received by electronic mail on April 25 requesting an amendment to permit No. 0730003-009-AC to provide for the possibility of having to startup the new combustion turbine and run in exclusively simple cycle mode throughout the summer. We understand that this may need to happen if further construction delays prevent the startup in combined cycle mode in time to meet the summer electrical generation demand requirements. While not in the original design to run for extended periods of time in simple cycle mode, we believe the permit does make provisions for simple cycle operation.

In addition, pursuant to Rule 62-210.300(3)(a) 34, Florida Administrative Code (F.A.C.), the proposed 28.8 MMBtu/hr natural gas-fired boiler needed to preheat the fuel for simple cycle operation is exempt from the requirements to obtain an air construction permit, provided that the boiler does not burn more than 150 million standard cubic of gas in a 12 month period. The PSD issue for CO emissions should not be a problem since the 99 ton per year increase authorized by this project includes emissions of CO from the duct burner. Since this 28.8 MMBtu/hr boiler will only be in operation when the 765 MMBtu/hr duct burner is not available, the total CO emissions for the year should be significantly less than if the duct burner was in operation for the entire year. Because fuel heating is required for simple cycle operation, it would be a good idea to consider adding the operation of a fuel heating boiler that meets the requirements of the categorical exemption to the list of insignificant emissions units available for use at the Hopkins facility the next time the Title V permit is opened for revision or renewal. As long as the insignificant unit is identified in the permit, then a rental boiler could be brought on-site if extended simple cycle operation is ever needed in the future.

If startup and continued operation in simple cycle mode is required throughout the summer, initial compliance testing will be required within 60 days of achieving the maximum production rate at

which the unit will be operated on natural gas (Permit No. 0730003-009-AC, Specific Condition 26.). Once the HRSG construction is completed, initial testing will need to be conducted for combined cycle operation on both natural gas and fuel oil.
