Building Ventilation Installation and Use of an Alternate Wood Species

Dear Mr. Aguilar:

On November 9, 2009, the Department received a request for an exemption regarding the installation of building ventilation and the use of an alternate wood species for the oriented strand board (OSB) facility. Based on our review of the proposed project, we have determined that the following additional information is needed in order to continue processing this application package. Please provide all assumptions, calculations, and reference material(s), that are used or reflected in any of your responses to the following issues:

1. On November 16, 2009, we received a response to an e-mail request sent November 12th regarding emission factors for the use of an alternate wood species. There were several pages of data submitted regarding the request. Based on the submittal, an e-mail request was sent on November 17th requesting that the information be reduced to a level that clearly supports the proposal so that any increase in emissions from the change can be easily discerned. Please be very specific and identify the pages and parts that you believe apply to the review of the proposed project. Also, provide the reference to a page or table from which the information was obtained.
2. Regarding the use of an alternate wood species, provide the sulfur and volatile organic compounds constituents of both the existing wood species currently being used and the proposed alternate wood species.


The above information is requested pursuant to the following Florida Administrative Code (F.A.C.) regulations: Rule 62-4.050 (Procedures to Obtain Permits and Other Authorizations; Applications); 62-4.055 (Permit Processing); 62-4.070 (Standards for Issuing or Denying Permits; Issuance; Denial); 62-4.120 (Construction Permits); 62-204.800 (Federal Regulations Adopted by Reference); 62-212.300 (Permits Required); 62-210.370 (Emissions Computations and Reporting); 62-210.900 (Forms and Instructions); 62-212.300 (General Preconstruction Review); and 62-212.400 (Prevention of Significant Deterioration). All applications for a Department permit must be certified by a professional engineer registered in the State of Florida pursuant to Rule 62-4.050(3), F.A.C. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the authorized representative or responsible official.

We will resume processing your application after receipt of the requested information. You are reminded that Rule 62-4.055(1), F.A.C. requires applicants to respond to requests for information within 90 days or to provide a written
