In response to Mr. Sheplak's letter dated April 5, 2002 dated April 5, 2002 we hereby provide notifications that our facility located at 1512 38th Avenue East, Bradenton, FL is subject to the EPA's MACT regulations. The specific information pertaining to the site is as follows:

1. (a) Site Name and Address: Oshkosh Truck Corporation – Florida Division
1512 38th Avenue East
Bradenton, FL 34208
1. (b) Facility Description: The facility manufactures and assembles transportation products for military and commercial use. Manufactured or remanufactured components are subsequently painted in any of five collectively regulated paint spray booths. A drying booth is also included. A wide variety of one and two part paints, diluents and solvents are used in the painting operation. Also included are miscellaneous exempt emission units and/or activities.
2. Identification of the MACT Source Category: Miscellaneous Metal Parts (Surface Coating)
Industrial Process Heaters (for the drying booth)
3. List of Emission Units: EU I.D. No. 002 – Painting Operations, including five collectively regulated paint spray booths, drying oven, and associated solvent clean-up.
4. We have not identified any affected source at the facility for which a Section 112(g) MACT Determination has been made.




