
Re: Title V Permit No. 0830024-010-AV Notice of Additional Responsible Official

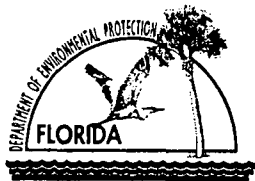


