On 10/30/02 Flair Manufacturing submitted an application for renewal of their FESOP for a metal products fabrication and surface coating facility.

The renewed permit is basically the same as the previous permit with the following changes:

- Sandblast Room No. 2 was removed in June 2002 and was taken out of the permit (with a note).
- Several things listed on the Insignificant Activities list that are no longer onsite were removed from the list.
- After discussion with EP, a total HAP recordkeeping requirement was added (previously not required due to the very low level of actual VOC (< 2 TPY) and HAP emissions.) The VOC recordkeeping requirement (which now also includes total HAPs) was also completely rewritten.
- The language and rule references of some of the permit conditions were updated
- The permit conditions were extensively reorganized, with the facility-wide conditions moved up from into Section A, and some conditions moved from the EU sections to the facility-wide section.

Required VE testing was conducted on 10/15/02 and showed compliance with the permit limitations. Compliance and Enforcement staff were sent an email (by EP) requesting any comments on this facility. Sheila S. responded that there were no enforcement issues. There was no response from compliance.

Due to the nature of the operations and the very low level of actual VOC and HAP emissions, this facility is still considered a natural minor source of VOC and HAPs.

I recommend that this renewal operation permit be issued as drafted and submit it for your review and approval.
