Dear Mr. DuPlessis:

Your facility's initial Title V Permit was issued on July 31st, 2005. On August 25, 2005, the regulations at 40 CFR Part 63, Subpart WWWW, National Emissions Standards for Hazardous Air Pollutants: Reinforced Plastics Composite Production, were revised and became applicable to your facility. Since the additional applicable requirements became applicable to your facility and there is more than 3 (three) years left on your permit as of the effective date of the new regulations, the Department is required to open your Title V Permit for cause and install these requirements in accordance with Rules 62-4.080(1) and 62-213.430(4), F.A.C., and 40 CFR 70.7(f). In order to incorporate the specific applicable requirements of 40 CFR Part 63, Subparts A and WWWW into your Title V Permit, please provide the specific rule citations of these applicable regulations for your facility and affected emissions units within 30 days of receipt of this letter.
