**PUBLIC NOTICE OF INTENT TO ISSUE AIR PERMITS**

FPL Martin Power Plant - Martin County

The Department of Environmental Protection (permitting authority) gives notice of its intent to issue an Air Construction Permit Modification (AC PSD) and an Air Operation Permit (AO PSD) to the Florida Power & Light Company for the Martin Plant, located in the unincorporated area of unincorporated Martin County, approximately seven miles north of Indiantown, on State Road 710. The applicant's name and address are Mr. Craig Arcari, Plant Manager, Florida Power & Light Company, 700 University Boulevard, Juno Beach, FL 33408.

This facility consists of two oil and natural gas fired conventional steam electric generating stations (Units 3 and 4) and two natural gas fired combined cycle units (Units 5 and 6). Unit 3 is a nominal 1,150 megawatt (MW) unit that began operation in 1970. It consists of four combustion turbine/hot recovery steam generator (CTHMSGI) sets and a nominal 420 MW steam turbine electric generator (STG). Pointloads from Unit 8 are controlled by use of inherently clean/natural gas, Dry Low NOx/CD combustors, and selective catalytic reduction (SCR).

All physical construction related to Combined Cycle Unit 8 is complete and the unit is in operation. A modification of the draft Unit 8 Air Construction (PSD) Permit will be issued that will allow excess emissions from the new CTMSGI sets during a period of time after the site has come online during start-ups of the 470 MW STG. Such cold startups of a STG are infrequent and typically years apart for back loaded combined cycle units.

The Draft Air Construction/PSD Permit Modification addresses a request by FPL to allow annual testing of Units 3 and 4 to be conducted at 90 to 100 percent of capacity rather than 85 to 100 percent. The request is consistent with the requirements in the original Air Construction/PSD Permit for Units 3 and 4.

The Martin Plant is currently undergoing a major modification to the plant's air handling equipment. This is a feature included in the original design and actual construction of Units 3 and 4 within the permitted heat input and emission limits.

The DRAFT Tide V Operation Permit Revision incorporates the conditions of the Unit 8 Air Construction/PSD Permit as well as the Draft Air Construction Permit Modification.

The Department of Environmental Protection (the "Department") and the PROPOSED Tide V Air Operation Permit Revision are subsequent FINAL Tide V Air Operation Permit Revision, in accordance with the conditions of the Draft Air Construction Permit Modification and the DRAFT Tide V Air Operation Permit Revision unless a response received. In accordance with the following procedures results in a different decision or significant change of terms or conditions.

The Department will accept written comments concerning the Draft Air Construction Permit Modification (including the toll of 30 days from the date of publication of this Notice) written comments should be provided to the Department's Bureau of Air Regulation, 2600 Blair Stone Road, Mail Station #6505, Tallahassee, Florida 32399-2400.

Any written comments filed shall be made available for public inspection. If written comments received result in a significant change in this Draft Air Construction Permit, the Department shall issue a Revised Draft Air Construction Permit and require, if applicable, another Public Notice.

The Department will accept written comments concerning the DRAFT Tide V Air Operation Permit Revision a toll of 30 days from the date of publication of this Public Notice. Written comments must be post-marked and all formal comments must be received by the close of business (5:00 p.m.) on or before the end of this 30-day period, by the Department at 2600 Blair Stone Road, Mail Station #6505, Tallahassee, Florida 32399-2400 or facsimile (850)922-6979.

As part of his or her comments, any person may also request that the Department hold a public meeting on this permitting action. If the Department determines there is sufficient interest for a public meeting, it will be held within the time limit.

Information on the Public Meeting will be available in the Florida Administrative Weekly (<http://www.dsw.state.fl.us/>) and in a newspaper of general circulation in the area affected by the permitting action. For additional information, contact the Department at the above address or phone number.

If written comments or comments received at a public meeting result in a significant change to the DRAFT Tide V Air Operation Permit Revision, the Department shall issue a further revision to the DRAFT Tide V Air Operation Permit Revision, if applicable, another Public Notice. All comments filed will be made available for public inspection.

A person whose substantial interests are affected by the proposed permitting decision may petition for an administrative hearing in accordance with Sections 120.569 and 120.57 of the Florida Statutes (F.S.). The petition must contain the information set forth below and must be filed in the Office of General Counsel of the Department of Environmental Protection, 2600 Blair Stone Road, Mail Station #6505, Tallahassee, Florida 32399-2400, telephone (850)922-6942, fax (850)922-2455. Petition must be filed by any persons other than those entitled to written notice under Section 120.603, F.S., must be filed within 14 (fourteen) days of publication of the public notice or within 14 (fourteen) days of receipt of the notice of intent, whichever occurs first. Under Section 120.603, F.S., however, any person who asked the Department for notice of agency action may file a petition within 14 (fourteen) days of receipt of that notice, regardless of the date of publication. A petitioner shall make a copy of the petition to the agency or representative of the person named above in the notice. The filing of a petition for hearing within the applicable time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliance with Rule 28-10.02-05 of the Florida Administrative Code (F.A.C.).

A petitioner may dispute the material facts on which the Department's action is based and must contain the following information:

- The name and address of each agency affected and each agency's file or identification number, if known;
- The name, address and telephone number of the petitioner, name, address and telephone number of the petitioner's representative, if any, which shall be the address for service purposes during the course of the hearing; and an explanation of how petitioner's substantial rights will be affected by the agency determination;
- A statement of how and when the petitioner received notice of the agency action or proposed action;
- A statement of all disputed issues of material fact, if there are none, the petition must so state;
- A concise statement of the ultimate facts alleged, as well as the rules and statutes which entitle petitioner to relief;
- A statement of specific rules or statutes the petitioner contends require reversal or modification of the agency's proposed action;
- A statement of the relief sought by the petitioner, stating precisely the action petitioner wishes the agency to take with respect to the agency's proposed action.

A petitioner that does not dispute the material facts upon which the Department's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-10.02-01, F.A.C.

In addition to the above, pursuant to 42 United States Code (U.S.C.) Section 7651(b)(1)(B), any person may petition the Administrator of the EPA, within 30 (thirty) days of publication of this notice, for review and reversal of the action taken by the Administrator of the EPA under 42 U.S.C. Section 7651(b)(1), to object to issuance of any permit revision. Any petition shall be based only on objections to the permit revision that were raised with reasonable specificity during the 30 (thirty) day public comment period provided in this notice, unless the petitioner demonstrates to the Administrator of the EPA that it was impracticable to raise such objections within the comment period or unless the grounds for such objection arose after the comment period. Filing of a petition with the Administrator of the EPA shall not affect the effectiveness of any other review or appeal available at 42 U.S.C. Section 7651(b)(1); the petition filed with the Administrator of the EPA at U.S. EPA, 401 M Street, S.W., Washington, D.C. 20460.
