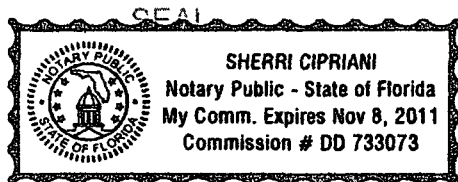

UNTANGLING THE WEB

Cooking sites abound on the Web, and while some include video demonstrations alongside their recipes, tips and techniques, this one has made the choice to base itself solely in the video format. Its goal, according to its "About" page, is to "help you become a better and more confident cook by teaching you basic to advanced cooking skills and techniques." Content is divided into three sections: "Cooking School," "Video Recipes," and "Tips and Techniques." Within each section are dozens of well-produced, thorough videos providing much easy-to-follow instruction and explanation. A great stop for both novice and experienced cook.

A. Look to see what kind of file is attached to the e-mail and what the extension of that file is. For example, if it is ".doc" then you know that the file is a Microsoft Word file.

After determining that, save the file to your Desktop, right-click over it, and select "Open With..." from the menu that appears.

From there, a window should open with a list of programs. Simply select the program you want to open the file in (example: Microsoft Word) from the list and check the box toward the bottom of the window reading, "Always use this when opening this type of file," and click OK. That should solve the problem.

Bob Connolly, Sebastian A. First, make sure you have the most current Windows Updates from www.windowsupdate.com, as these are required for Vista compatibility. After that, and if you still have problems, try completing the following:

- Click Start, then Accessories, then Run. Type "regedit" (without quotes) in the blank provided and select OK. This will open your Windows Registry.
- Navigate to the following path in the window that opens via the left-hand column (doing so will be similar to navigating through your Windows folders):

HKEY_CURRENT_USER\Software\Microsoft\Windows\CurrentVersion\WorkFolders\

- Once there, right-click on the Quattro Pro folder, select "Rename" from the menu that appears, and rename the folder to "Quattro Pro old." (Note: This will not alter your Quattro Pro program in any way. Quattro Pro should still launch fine for you.)

Doing this will force Quattro to make a new version of the folder for Windows registry and should solve the issue.

FAU to test alert system Thursday

Florida Atlantic University will be testing all components of its alert system Thursday morning.

At about 9:55 a.m., the emergency siren and PA system will be activated on FAU's Boca Raton campus, 777 Glades Road, as well as at FAU's John D. MacArthur campus, 5353 Parkside Drive in Jupiter.

A loud siren sound and a spoken message will be heard across campus, as well as in neighborhoods and business areas near the campuses.

Additionally, FAU's university-wide e-mail, telephone alert, Web alert, text messaging and emergency hotlines will be tested in the afternoon. The toll-free emergency hotline phone number - (888) 8FAU-OWL (8328-695) - will be tested, which allows callers to access all FAU emergency updates for each of its campuses via one phone number.

PALM BEACH COUNTY

Southern boundary officially moves north

For the first time since Martin County separated from it in 1925, Palm Beach County's boundary has changed. The "Wedge," a 3-square-mile tract in the southwestern part of Palm Beach County, is now officially part of Broward County.

State lawmakers originally approved the boundary change by adopting legislation in 2007 and became effective July 28.

The "Wedge," a triangular area comprised of 45 separate lots totaling 1,928 acres (2,029 including rights of way and water features), is west of the West Boca community and south of Lox Road, which parallels the Hillsboro Canal. The canal becomes Palm Beach County's new southern border, east of the Everglades.

Conveying the property gives Palm Beach County a more regular, geographically defined southern boundary.

Palm Beach County's land mass now stands at 1,976 square miles, according to county planners. It remains one of the largest counties east of the Mississippi River.
