Dear Mr. Piper:

This letter is in reference to the List of Insignificant Activities, "Attachment PMRFS_7.doc," submitted with the subject application.

Your portrayal of the information on the attached listing suggests that the industry listings of insignificant activities exempt certain activities. I understand what you mean, but want to clarify how it really works.

The Title V application should provide a listing of activities for which exemption is requested and justification for the request. For those activities listed at Rule 62-210.300(3), F.A.C., a citation of the rule is the justification. For those activities identified as "presumptive exemption," you may cite those words which means that they have been pre-reviewed by the Department. For any additional activities, you need to show detailed quantitative justification. For all of the above, except those activities listed at Rule 62-210.300(3), F.A.C., the permitting authority makes the final decision of whether they will be exempted, except that any activity not listed at Rule 62-210.300(3), F.A.C., and not listed as "presumptive exemption," needs to be approved by the Tallahassee office (DARM).
