Tom,

Please process a letter of authorization for the requested excess emissions. Use projects 0850001-023 and 025-AC as templates. Make sure this time the part that suggests FPL revise their AC permit to allow for these excess emissions due to tuning is highlighted or bolded so they will go ahead and schedule a revision to the AC permits for all of their units.

Looks like we will not have to do this for the Unit 8 upgrade project when they finish it, the permit already allows for CEMS exemptions due to tuning:

**E.15.DLN Tuning.** CEMS data collected during initial or other major DLN tuning sessions shall be excluded from the CEMS compliance demonstration provided the tuning session is performed in accordance with the manufacturer's specifications. A "major tuning session" would occur after completion of initial construction, a combustor change-out, a major repair or maintenance to a combustor, or other similar circumstances. Prior to performing any major tuning session, the permittee shall provide the Compliance Authority with an advance notice that details the activity and proposed tuning schedule. The notice may be by telephone, facsimile transmittal, or electronic mail. [0850001-010-AC; and Rule 62-4.070(3), F.A.C.]

Robert, please check the excess emissions provisions in Sanford's permit. If it does not allow for tuning, please add the above condition to your current project and all future projects of this sort.

Lynn, please log this AC project for Tom and let him know what the number is.
