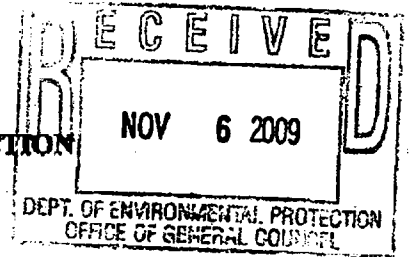

REQUEST FOR EXTENSION OF TIME


Petitioner, ORLANDO UTILITIES COMMISSION, INC., (hereafter "OUC") hereby requests an extension of time to file a petition for formal administrative hearing challenging the action of the Department of Environmental Protection ("Department") proposing to issue with conditions a permit to OUC for operation of the OUC Stanton Energy Center facility and states:

1. By Notice of Intent to Issue Title V Air Operation Permit, dated October 26, 2009, the Department proposed to issue a permit to OUC to operate the Stanton Energy Center in Orange County, Florida (Permit No. 0950137-027-AV).
2. The Notice was sent by electronic mail to Mr. Jan C. Asparu, Vice President of Power Resources, on October 26, 2009.
3. Under the notice of rights, OUC has 14 days from "receipt of this written notice" to file a petition for hearing challenging the proposed permit.
4. OUC has reviewed the proposed permit and noted several conditions which OUC might seek to modify.
5. Prior to filing a petition for administrative hearing to seek changes, however, OUC would like an opportunity to discuss the proposed permit with the Department to determine the need to take such action.

NOW THEREFORE, OUC requests that the Department grant its request for an extension of time to file a petition for hearing to and until December 4, 2009.
