facility Location: OUC operates the exist ing Curtis H. Stanton Energy Center which is located in Orange County a 5100 South Alarfay Trail, Orlando Florida. OUC Stanton Units 1 and 2 are coal fired boiler/steam generators and steam furbines, each with a 468 megawatts nominal capacity rating. Unit is equipped with an electrostatic precipitator for control of particulate matter, and a wet flue gas desulfurization (WFGD) system for sulfur dioxide (SO2) control. Unit 2 is equipped with an electrostatic precipitator for control of particulate matter, as wet flue gas desulfurization (WFGD) system for sulfur dioxide (SO2) control, and selective catalytic reduction (SCR) to control nitrogen oxides (NOX).

Project: OUC applied on June 11, 2012, to the Florida Department of Environmental Protection for a permit: to install a selective catalytic system (SCR) for Unit 1; to add dry sorbent injection (DSI) systems to Units 1 and 2; and, to conduct additional upgrades to the WFGD system on Unit 1. The proposed WFGD upgrade includes: installation of a new distribution tray or wall rings; modifications to the spray headers and nozzles; and modifications to the induced draft fan. These modifications are expected to reduce the operating costs of the Unit 1 scrubber system and improve its reliability. Emissions of sultry dioxide (SO2) are expected to decrease as a direct result of the improved efficiency of the WFGD system. Emissions of nitrogen oxides (NOX) are also expected to decrease as a direct result of the improved efficiency of the improved efficiency of the consideration of the SCR system.

The project is part of a continuing program at the OUC Curtis H. Stantor Energy Center to reduce emissions of SO2 and NOX for the purpose of complying with the Cross-State Air Pollution Rule (CSAPR) and the Mercury and Air Toxics Standards (MATS). The Department has reasonable assurance that the project will not result in significant net emission increases from the units that would otherwise require a review under the Rules for the Prevention of Significant Deterioration (PSD) at Paragraph 62-212.400, or 40 Code of Federal Regulations, Part 52, Section 52.21.

Permitting Authority: Applications for air construction permits are subject to review in accordance with the provisions of Chapter 403, Florida Statutes (F.S.) and Chapters 62-4, 62-210 and 62-212 of the Florida Administrative Code (F.A.C.). The proposed project is not exempt from air permitting requirements and an air permit is required to perform the proposed work. The petition must contain the information set forth below and must be filed with (received by) the Department's Agency Clerk in the Office of General Counsel of the Department of Environmental Protection at 3900 Commonwealth Boulevard, Mail Station #35, Tallahassee, Florida 2339-3000. Petitions filed by any persons other than those entitled to written notice under Section 120.60(3), F.S. must be filed within 14 days of publication of this Public Notice or receipt of a written notice, whichever occurs first.
