Dear Mr. Murray:

On July 7, 2008, the Department received a Title V air operation permit renewal application for the subject facility. Thank you for using the latest version of the air permit application form.

In order to continue processing your application, the Department will need the additional information requested below. Should your response to any of the below items require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the application form.

 New Applicable Requirements: On February 24, 2004, the U.S. EPA promulgated the Reciprocating Internal Combustion Engines (RICE) Maximum Available Control Technology (MACT) 40 CFR 63 Subpart ZZZZ for engines. The RICE MACT applies to new and existing engines. Florida adopted this regulation by reference at Rule 62-204.800(11)(b)82., F.A.C.

In Appendix U-1, List of Unregulated Emissions Units and/or Activities (attached as part of Permit No. 0950203-006-AV, Effective January 1, 2004) "emergency generators" are listed as emissions unit identification number -003.

a. Are any of the on-site "emergency generators" engines that are regulated under the RICE MACT?

If not, please provide key non-applicability descriptors to show that these engines are clearly not subject to the RICE MACT, like 'existing,' model year/construction date, size of engine, e.g., equivalent brake horsepower (HP), type of engine, e.g., compression ignition (CI), etc.

The Department will resume processing the application after receipt of the requested information. Rule 62-4.050(3), F.A.C. requires that all applications for a Department construction permit must be certified by a professional engineer registered in the State of Florida. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the authorized representative. You are reminded that Rule 62-4.055(1), F.A.C. now requires applicants to respond to requests for information within 90 days or provide a written request for an additional period of time to submit the information.

The processing of this application is under time constraints due to acid rain requiring this permit to be effective January 1, 2009. To be effective January 1, the Draft permit needs to be issued by October 3, 2008. A response no later than **September 28, 2008** is appreciated.
