ST. CLOUD GENERATION STATION NOTIFICATION OF FACILITY SHUT DOWN FACILITY ID NO. 0970002

Dear Mr. Holtom:

Orlando Utilities Commission (OUC) is contracted to perform operations and maintenance functions at the above-referenced St. Cloud Generating Station under an interlocal agreement with the City of St. Cloud. The facility, consisting of diesel-fired generating units and other miscellaneous insignificant emission units, commenced operation in the 1950s. OUC had previously notified the Department by letter, dated June 27, 2008, that the facility was being placed into an extended cold shutdown. Subsequently, OUC and City Of St. Cloud management has evaluated future demand and potential operation of this facility and determined that it is not longer economically feasible to operate these units in today's environment due to their age, condition, and overall reliability. The determination has been made that the most prudent course of action is to permanently shut down the facility. OUC has reviewed the applicable requirements and our understanding is summarized below.

- The current TV permit (0970002-003-AV) was issued on March 1, 2007 and expires on February 28, 2012. This letter serves to provide notice to the Department that OUC does not intend to renew the TV permit.
- The facility has been continuously shut down since the notification letter was submitted (June 27, 2008) and there have been no emissions.
- OUC has continued to submit an annual operating report (AOR) every year; even though
  it was only to indicate that the facility did not operate. In addition, OUC also submitted an
  annual TV Statement of Compliance (SOC), pursuant to the Title V permit, indicating that
  the facility did not operate. Finally, OUC has submitted the annual emissions fee and
  form every year, accompanied by the minimum \$250 fee.
- In addition, OUC will submit an AOR, an annual TV SOC and an annual emissions form and fee for calendar year 2011. OUC requests that this requirement be waived for calendar year 2012 reporting, as the permit will not have been in effect for more than two months in this calendar year.
