Title V Air Operation Permit Revision Application

Dear Mr. Priore:

On November 12, 2009, the Department received a Title V air operation permit revision application for the subject facility via hard copy submission. Thank you for using the latest version of the air permit application form. The FPL-West County Energy Center is located at 20505 State Road 80, Loxahatchee in Palm Beach County, Florida.

In order to continue processing your application, the Department needs the additional information requested below. Should your response to any of the below items require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the permit application form.

- 1. <u>Initial Compliance Testing</u>: The emissions units are required to demonstrate initial compliance while firing natural gas and fuel oil. The permit revision application indicated that Unit 1 has been initially tested while firing natural gas with the last test performed on October 8, 2009. Was compliance successfully demonstrated by Unit 1 while firing natural gas? Have all initial compliance test reports been submitted for Unit 1? The compliance plan in the permit application, Attachment FPL-FI-CV3B, indicated Unit 2 has not completed initial testing while firing natural gas. In this permit application it was indicated that Unit 2A (the latest turbine to start up) started up on September 22, 2009. Based on this date it seems the initial compliance testing is due to be completed by March 22, 2010 for Unit 2. Both Units 1 and 2 have not completed initial compliance while firing fuel oil. Please provide an update on the initial compliance testing. Where the initial compliance testing when firing fuel oil has not yet been done, has the capability to fire fuel oil been installed?
- 2. <u>Excess Emissions</u>: In the cover letter to the permit revision application, changes were requested to the specific conditions related to fuel switching and cold startup. The Department needs additional specific information related to excess emissions during fuel switching and cold startup.
  - a. <u>Fuel Switching</u>: Please provide specific information on how fuel switching takes place, preferably information from the equipment manufacturer/vendor.
  - b. <u>Cold Startup</u>: Please provide the sequence of events for a cold startup, preferably information from the equipment manufacturer/vendor.
- 3. <u>Facility Plot Plan</u>: Please provide an enlarged plot plan identifying the emissions units. The plot plan in Attachment FPL-Fl-C1 is very small. A larger plot plan can provide a better illustration of the layout of the equipment at the site.

4. <u>Auxiliary Boiler</u>: On December 3, 2009, the Department issued Permit No. 0990646-003-AC, which affected the auxiliary boiler. Does Permit No. 0990646-003-AC alter the permit revision application form submitted? If so, please submit the revised affected page(s) of the form.

The Department will resume processing your application after receipt of the requested information. Rule 62-4.050(3), Florida Administrative Code (F.A.C.) requires that all applications for a Department Title V air operation permit must be certified by a professional engineer (P.E.) registered in the State of Florida. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the responsible official (R.O.).

Rule 62-4.055(1), F.A.C. now requires applicants to respond to requests for information within **ninety (90)** days or provide a written request for an additional period of time to submit the information.
