Thank you for your recent submission of the Title V Air Operation Permit Application for the subject facility received in our offices on April 1, 2002. However, we must deem your Application *incomplete* because of the following reason:

- Full demonstration of compliance with the terms and conditions of air construction permit PSD-FL-280 for the three simple-cycle combustion turbines at the facility was not included. We note that the existing construction permit expires on July 1, 2002. If testing of the emissions units is underway, or currently planned, please provide us with an appropriate *compliance plan* that includes date estimates of test completion. This plan will then be incorporated in the DRAFT Title V Permit for the facility.
