After review of your letter dated July 13, 2010, we confirm that the methodology you present is consistent with the current requirements of Conditions B.9 and B.95 of the permit with regard to the monthly and annual average daily charging rates. This interpretation is based solely on permit conditions B.9 and B.95 as written. You are reminded that Condition B.9 also establishes a short-term capacity based on a 4-hour block average of the steam production rate.
